Subject: Information/Instructions regarding various matters of colleges

Sir/Madam.

The recommendations approved by the Vice-Chancellor, in anticipation of the approval by the Academic Council, during the meeting held on 3.5.2018 for matters related to colleges put up by the Federation of Colleges (PUDCA), are being enumerated as follows:

- 1. The migration fee charged from a student migrating from one college to another under Punjabi University jurisdiction has been increased from Rs. 7500/- to Rs.10,000/-
- 2. The date of admission of students from outside Punjab/ foreign countries, is informed to be fixed according to the admission date of re-appear students within 10 days of the declaration of their result, without late fees. After that late fee will be charged as per the prescribed schedule of admissions, after which permission for admission will not be granted.
- Regarding lateral entry admission for MCA classes, provision has been made for admission to this class on the university campus as well, and ditto provisions should be made in colleges affiliated with the university for admission to lateral entry MCA courses.
- 4. For fees related to BA/Bed/B.Com.- BA/B.Sc. B.Ed. (four-year integrated program), it is informed that their fee for the first two years will be charged the same as for BA/BSc/BCom classes and for the last two years as fixed for B.Ed. classes.
- 5. Regarding allotment of seats in undergraduate and graduate programs it is notified that for all undergraduate programs barring BA, a unit of 50 seats will be applicable and one unit of 40 seats for PG programs is being fixed. But, as the B.Com. course already has 60 seats per unit allotted, therefore, it will remain the same. During the inspection by the Inspection committee appointed for these courses, in case the seats are reduced for any course owing to discrepancies on the part of the college, the unit will be curtailed but the fee for the course will be charged as applicable to the full unit. It is being clarified here that in programs where seats are defined by certain Regulatory Bodies, the above-mentioned rule will not be applicable there.
- 6. Regarding the advertisement for the post of Principal/staff through the college website instead of the newspapers, it is specified that the advertisement be published both on the website as well as in the newspapers and when the advertisement is given in the newspapers it must be compulsorily specified that the college website can be consulted for related details of the posts advertised.

- 7. NOC from the govt. of Punjab will not be required to convert girls' colleges, running under Punjabi University, into co-ed colleges, but only for getting CLU for the purchase of extra required land and approval for building from Chief Town Planner, it is notified that it will be mandatory to take approval from-(i) the Chief Town Planner for the blueprint of the building and (ii) approval for the land for being at a single location from Tehsildar/ Finance Department. Also, an FDR will be necessary for the endowment fund earmarked for the co-education college as well as for the related charges. It is also mandated that the conversion of the girls' college into a co-education one will be undertaken under the supervision of the report and recommendations of the inspection committee.
- 8. Provision is made to give a chance on a priority basis, to those students who have secured a re-appear in their final year of examination.
- 9. Strict disciplinary action will be taken against those colleges that offer admission to students without collecting their migration certificates.
- 10. To appoint a Principal in a degree or B.Ed. college where the campus has been converted into Composit-campus, it has been mandated in the meeting held on 11.10.2017, that as per the regulations of NCTE 2014, the Principal who is currently approved and working in both colleges (Degree & B.Ed. college) managed by the same management, shall continue to work in the same form, but if a Principal hasn't been appointed in both colleges, a Principal will be appointed for the degree college and the same Principal will work for the B.Ed. college as well, and a B.Ed. college head should also be appointed for the B.Ed. college.
- 11. In case an approved Principal/Faculty member working in a college under the University is selected to work for another college under the university and he/she hasn't achieved any extra eligibility qualifications, then, the said Principal or faculty member wouldn't require Approval letter from the university to work in the new college.
